why:	financial companies choose how they share your personal information. federal law gives consumers the right to limit some but not all sharing. federal law also requires us to tell you how we collect, share, and protect your personal information. please read this notice carefully to understand what we do.

what we do:

how does intellicents protect my personal information?

to protect your personal information from unauthorized access and use, we use security measures that comply with federal law. these measures include computer safeguards and secured files and buildings.

how does intellicents collect my personal information?

we collect your personal information, for example, when you:

- open or close an account
- authorize a trade or authorize a direct fee-deduction
- authorize to raise cash
- have a financial plan prepared

we may also collect your personal information from other companies.

why can't I limit all sharing?

federal law gives you the right to limit only:

- sharing for affiliates' everyday business purposes – information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

state laws and individual companies may give you additional rights to limit sharing.

what does intellicents do with my mobile information?

by providing your mobile phone number to intellicents, you agree and acknowledge that intellicents may send text messages to your mobile phone number. message and data rates may apply. message frequency may vary. you may opt-out at any time by replying "stop".

no mobile information will be shared with third parties/affiliates for marketing/promotional purposes. notwithstanding any other statement within this privacy policy, originator opt-in data and consent will never be shared with any third parties.

definitions:

affiliates

companies related by common ownership or control. they can be financial and nonfinancial companies.

intellicents investment solutions inc. is affiliated with the intellicents group of companies: intellicents, inc.; intellicents evergreen llc; intellicents of pella, llc; intellicents lone star llc; and intellicents twc llc.

non-affiliates

companies not related by common ownership or control. they can be financial and nonfinancial companies.

these include broker/dealers, mutual fund companies, insurance companies and other financial institutions.

joint marketing

a formal agreement between nonaffiliated financial companies that together market financial products or services to you.
