Item 4- Other Business Activities

intellicents investment solutions inc. is part of a consortium of companies that focus on providing employee benefit services to employers. The services include investment advisory services provided through iis, and through its affiliated companies: life, disability and health insurance services, and benefits consulting services that range from defined contribution retirement Plans to employee wellness programs.

For services provided by the affiliated intellicents investment solutions companies, the companies and Misael Herrera Granados may receive consulting fees and/or commissions on sales of any investment and insurance product sold to clients. iis may also provide investment advisory services to the clients of the affiliated intellicents investment solutions companies; however, iis never receives commissions on any assets under management for which iis receives advisory fees.

1. Mr. Herrera Granados is also registered as an Investment Advisor Representative (“IAR”) with another Registered Investment Adviser (“RIA”) outside of intellicents called True Wealth & Company LLC*. Mr. Herrera Granados spends approximately 180 hours per month in this capacity.

2. Mr. Herrera Granados is also a Marketing Assistant in Clinical Research for Johnson County Clinical Trials. As a Marketing Assistant, Mr. Herrera Granados produces online content and aids with outbound marketing activities and events. Mr. Herrera Granados spends approximately 80 hours per month of his time in this capacity.
